### SYSTEM REQUIREMENTS AND INSTALL

#### System Requirements:

- Microsoft Windows XP, Vista or 7, 8.1,10 (32 bit or 64 Bit OS)
- Intel or AMD 600 MHz class processor (1 GHz or higher recommended)
- 1G RAM Minimum (higher recommended)
- 500MB hard disk space minimum (Additional space is required to store the project files that are created using StreamNet Dealer Setup based on the project file size)
- Ethernet Network Interface to connect your computer to StreamNet Network
- Admin permission to install the software
- Adobe® Flash® must be installed using Internet Explorer™ web browser.

#### Download

Download the **StreamNet Application Suite 03.01.23.zip** file containing the application from the ClearOne web site Resource Library. The file will be visible and available for downloading. The file is password protected intended for registered partners/technology specialists who will receive the password by email. #### Install

After successfully downloading the zip file containing the application, open it and run the included program and follow the instructions provided.

#### Uninstall

It is not mandatory to uninstall the previously installed StreamNet Application Suite.

## NEW FEATURES ADDED

- Added PANORAMA software license for Video Composition & Video Wall feature for VIEW Pro Encoder, Decoders
- User name & password authentication support for RTSP/UDP Streams. Some IP cameras and 3rd party services may need user authentication to access their streams.
- Added support for Text overlay for streams
- Added showing volume bar for Decoder
- Added support for screen rotation (0, 90, 180, 270)
- PANORAMA software can be standalone application and also can be launched from Dealer Setup software.

## KNOWN ISSUES

- Selecting video source for audio only renderer in VIEW Pro Decoder may cause disruption in the video output. The work-around is to create audio-only stream for this source and select this stream for audio only renderer.
- The D110 and D210 Decoders does not support 1080i (interlace mode).

## NEW FEATURES ADDED

- Added UDP stream support in VIEW Pro Encoder in addition the existing RTSP stream. The multicast stream is a software license feature. The unicast stream is enabled by default without license.
- RTSP/UDP stream license feature for VIEW Pro Decoders. Now decoders can receive H.264 stream from 3rd party devices through RTSP/UDP.
- Local playback license feature for VIEW Pro Decoders, to play supported videos from USB thumb drive.
- Added support to allow configuring multiple RTSP and UDP Streams

## BUGS FIXED IN THIS RELEASE

- Added support in the Dealer Setup software to set the blocking time interval for source switching
- Sometimes the screen shows black screen while playing video.
- Sometimes the unit turns to Green LED from Blue LED though the unit functionally working fine.
- Encoder IR output control is not working sometimes.
